Attached and below are some materials that you can give to the PR firms when they are evaluating the situation and the appetite to take this on and work with Swiss-based (or international if they think they have the contacts) journalists. What we are looking for is basically a journalist willing to write the true story. The story out now is a simple one of whistleblowing where the means justify the ends – so basically they committed crimes but they were uncovering crimes, so it is ok. However the true story is one of people with no intention of whistleblowing but rather a greedy former ex-employee only motivated by money and opposition politicians who used him for their political goals. There is no whistleblowing, just crimes of dealing in stolen goods, money-laundering and using a poor Swiss guy for political gain. Somebody has to be interested in that story and getting the truth out there. Preferably a journalist who doesn't like Le Temps and their editorial freedom and lack of fact checking (they are completely in bed with Clare Rewcastle Brown (who has the most to lose if the truth gets out) and they have confirmed to Laura Justo that they are working with her). We can offer a lot of case evidence to back these claims. If someone willing to take this on as well as interviews with Xavier and Laura Justo, Malaysians and PSI. let me know how you get on. Unfortunately a story of corruption is a better story than a mad former PR Minister's sister-in-law committing crimes to overthrow an democratically elected government, however that is the true story – so hopefully some journalist is interested in being the one with the true story. **Whatever you give them, please make sure my name is not on it.** Best to just let them read this stuff only for now and then take it back. Whoever we decide to work with can then keep copies and also get the supporting evidence. You should also mention confidentially that there will be arrests in Singapore and the UK, so serious jurisdictions)

Xavier Justo Update – 24.7.15

Arrest & Confession

Justo has been arrested and is being held in Bangkok Remand Prison in Thailand.

The Royal Thai Police (RTP) have confirmed that Justo has confessed to the crimes with which he was charged and also to other actions by himself and others that likely constitute crimes in a number of countries.

We understand from the RTP that his confession covers the following:

- a. Admitting to Attempted Blackmail
- b. Admitting to Attempted Extortion
- c. Admitting to Theft of Data
- d. Admitting to selling the Data to Clare-Rewcastle Brown, Tong Kooi Ong (the owner of The Edge) and Hoy Kat Tat (the editor and CEO of the Edge) for \$2m.
- e. Admitting to participating in an attempt by Clare-Rewcastle Brown, Tong Kooi Ong and Hoy Kat Tat to launder the money to him via various methods and multiple countries.
- f. Suggesting that Clare-Rewcastle Brown, Tong Kooi Ong and Hoy Kat Tat tampered with the data.

We further understand that the RTP has obtained substantial evidence that corroborates the confession in the form of emails, WhatsApp messages and transcripts, phone records, flight records, hotel details, CCTV footage, signed agreements, etc.

We have been informed by the RTP that a full copy of all evidence, including Justo's written confession, will be made available once the Thai judicial proceedings have concluded. The evidence will be provided in documentary form, notarised by the Thai court. Expected ETA is approximately one month from today.

A summary of the key events and timeline as has been provided by the RTP is **attached**.

Legal analysis is ongoing to determine the crimes committed by the various named individuals in each country. Preliminary analysis suggests that:
